2. Minutes

This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on March 17, 2022.

3. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:

This resolution sets the date and time for a public hearing on June 2, 2022, at 4:00 p.m. to determine whether certain conditions of the properties located at 1816 N Arthur Street, 4613 Eagle Lane, 204 N Florida Street, and 606 S Florida Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.

4. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of four residential apartment structures and an accumulation of solid waste located at 510 SW 2nd Avenue (also known as 516 SW 2nd Avenue).

5. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 2419 NW 10th Avenue.
