2. **Minutes**
This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on April 7, 2022.
3. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**
This resolution sets the date and time for a public hearing on July 7, 2022, at 4:00 p.m. to determine whether certain conditions of the properties located at 4613 Meadowlark Drive and 4223 SW 12th Avenue constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 412 NE 10th Avenue.

This resolution conducts a public hearing on and considers ordering the removal of substandard structures and an accumulation of solid waste located at 1205 N Highland Street.
