A. Amarillo Police Department High Accident Locations

Chairman Rogers introduced Haley Hernandez with the APD. Haley is a Crime Data Analyst for the APD. APD has access to TXDOT's reporting system. Michael mentioned that Hillside & Soncy and Coulter & Hillside are mostly left turns accidents. There are four and five section heads out there. There really should be three section protective arrows only. Sleepy Hollow to Wallace has high accidents along with high congestion and we are going to be installing radar technology which will do traffic counts on the fly with access to data. There will be an Access Management Study coming down the road on some the major arterials. It's possible that left turns would be eliminated. An example would be; if you're coming out of a small business, you would have to make a right turn to go to a signalized intersection to make a turn and go back.

Haley presented the board the high accident locations. Soncy had the lowest compared to Coulter St. Soncy does have a median. Top citation is failure to control speed. Wednesday and Friday are the busiest days of the week for accidents. I-40 to 34th and 34th to 45th are the highest concentration of accidents.

B. Video Tour of Traffic Management Center has been tabled for the next meeting. Michael gave the Board a tour of the TMC.
