All or part of any agenda item may be discussed in an executive session at any time during a meeting, as may be necessary and allowed by state law. Votes or final decisions are made only in open Regular or Special meetings, not in a work session or executive session.

1. **Public Comments**
Interested citizens may comment on matters pertaining to policies, programs or action of the Condemnation Appeals Commission.

2. **Minutes**
This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on May 5, 2022.
3. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**
This resolution sets the date and time for a public hearing on August 4, 2022, at 4:00 p.m. to determine whether certain conditions of the properties located at 112 SE 40th Avenue, 1016 N Madison Street, 1303 N Spring Street, and 2300 Spruce Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.
4. **Resolution – Public Hearing**
This resolution conducts a public hearing on and considers ordering the removal of a substandard structure and an accumulation of solid waste located at 1816 N Arthur Street.

This resolution conducts a public hearing on and considers ordering the removal of substandard structures and an accumulation of solid waste located at 4613 Eagle Lane.
6. **Resolution – Public Hearing**
This resolution conducts a public hearing on and considers ordering the removal of an accumulation of solid waste located at 204 N Florida Street.
7. **Resolution – Public Hearing**
This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 606 S Florida Street.
