2. <u>Minutes</u>

3. <u>Resolution – Calling a Public Hearing to determine whether certain conditions described</u> <u>herein constitute a Public Nuisance at the locations stated:</u>

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 606 S Florida Street.
