This resolution sets the date and time for a public hearing on September 1, 2022, at 4:00 p.m. to determine whether certain conditions of the properties located at 410 NE 6<sup>th</sup> Avenue, 3809 SE 10<sup>th</sup> Avenue, 1945 NW 20<sup>th</sup> Avenue, and 505 N Madison Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.
