2. Minutes

This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on June 2, 2022.

3. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:

This resolution sets the date and time for a public hearing on September 1, 2022, at 4:00 p.m. to determine whether certain conditions of the properties located at 410 NE 6th Avenue, 3809 SE 10th Avenue, 1945 NW 20th Avenue, and 505 N Madison Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.

4. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 4613 Meadowlark Drive.

5. Resolution – Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 510 SW 2nd Avenue. The Commission previously heard and tabled this resolution at the regular meeting held on April 7, 2022.
