#### 3. <u>Resolution – Calling a Public Hearing to determine whether certain conditions described</u> <u>herein constitute a Public Nuisance at the locations stated:</u>

This resolution sets the date and time for a public hearing on October 6, 2022, at 4:00 p.m. to determine whether certain conditions of the properties located at 110 S Fairmont Street, 111 S Fairmont Street, 743 N Mirror Street, and 2501 SW 6<sup>th</sup> Avenue constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.
