REGULAR MEETING

Call to Order.

Item 2: Review of Minutes from Last Meeting.

Committee Chairman Rogers asked if there were any changes to make for the approval of the April 11, 2022, minutes. Committee Member Guengerich made a motion to approve the minutes. Committee Member Smith seconded the motion, and motion carried 6:0.

B. Update on Six Pack Outdoors in relation to Pedestrian and Bicycle Safety.

Committee Member Podzemny shared a handout with the Committee. Six Pack Outdoors has spent the last couple of months on the schoolyard pump track known as Tornado Alley. It's located on Eastern, South of 34th. They have collected 400 tires that have been dumped illegally from around the community to serve as a retaining wall for the pump track. Waiting on final approval from the State's Archeologist and City's Parks Department to continue development of the 9th Street Trails. It's made for any type of bicycle and fun for the family. It will be free and open for the public. There will a concession stand along with bathrooms. The pump track sits on 5 acres and is connected to the Rick Klein Trails. Amarillo has 50-60 miles of soft surface trails. Podzemny provided a page of grants for the committee to check out.

C. Presentation on process for acquiring right of way for future bike trails.

Donny stated that this would a process through our Engineering Dept. This would be a CIP item that would be added to a list of on-going projects. There are some easements Podzemny provided in the handout also. Some Transmission lines are 30 feet. Most maps of the easements are on the City's Website. There are very attractive areas in the Northwest side of Amarillo that should be looked at. Donny stated that the most restrictive are natural gas lines.

D. Discuss how to improve walkability in Amarillo.

Committee Member Guengerich discussed with the Committee on how to improve and would like to focus on the transportation and health. She would like to put together a walkability plan for Amarillo. The first thing she would like to do is conduct Audits which would be community based. There is a guidebook that AARP uses to help in this. Committee Member Landry will assist Guengerich and come back to the Committee.
