**2. Minutes**

This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on August 4, 2022.

**3. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**

This resolution sets the date and time for a public hearing on November 3, 2022, at 4:00 p.m. to determine whether certain conditions of the properties located at 508 N Madison Street, 317 Parker Street, 901 N Polk Street, and 2916 Trigg Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.

**4. Resolution – Public Hearing**

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure located at 410 NE 6th Avenue (AKA 516 N Pierce Street REAR).

**5. Resolution – Public Hearing**

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure and an accumulation of solid waste located at 3809 SE 10<sup>th</sup> Avenue.

**6. Resolution – Public Hearing**

This resolution conducts a public hearing on and considers ordering the removal of a substandard structure and an accumulation of solid waste located at 505 N Madison Street.
