Call to order. Sally Jennings established a quorum and called the regularly scheduled meeting of the Civil Service commission to order at 8:33am.

ITEM 1: Sally Jennings opened with the public address- no comments from the public on agenda items.

<u>ITEM 2</u>: Sally Jennings considered approval of the Minutes for the meeting held on March 25, 2022. Motion made by Lawrence Walker to approve. Seconded by Sally Jennings. Motion passed.

<u>ITEM 3</u>: Sally Jennings presented the approval of the list of new employees, step increases, transfers, promotions, demotions, bypasses, temporary assignments, and disciplinary actions. Lawrence Walker motioned to approve. Seconded by Sally Jennings. Motion passes.

<u>ITEM 4</u>: Sally Jennings presented to approve eligibility register for the position of Police Recruit for exam given on March 26, 2022. Lawrence Walker moved to approve. Seconded by Sally Jennings. Motion passes.

<u>ITEM 6</u>: Consider appeal filed by Firefighter Randal Johnson regarding questions 6,27 & 46, and by Firefighter Christopher Gibson regarding questions 6,10,86,88, and 97 on the Fire Driver exam.

Randal Johnson was called to the podium, he stated his name, address, and position with the Fire Department. He began to state his reasoning for his appeals to questions 6,27 and 46.

Questions #6- he stated that there were various references in the book related to the question and said there were more correct answers besides the keyed answer.

Question #27- stated there was more than one correct answer and wanted credit for the answer he chose.

Question #46- he referenced sections in the book stating that there was more than one correct answer and wanted credit for the answer he chose.

Christopher Gibson was called to the podium, he stated his name, address and position with the Fire Department. He began to state his reasoning for his appeals to questions 6,10, 86, 88 and 97. Question #6- he stated that he agrees with Randal Johnsons statement regarding there being more than one correct answer.

Question #10- he read the question from the exam and then the section in the book that referenced the question and answer. He felt that it was a bad question and requested that it be eliminated from the exam.

Question #86- He stated his reasoning why the question was a bad one and requested that the question be eliminated.

Question #88- stated his reasons why there was more than one correct answer and wanted credit for the answer he selected.

Question #97- stated his reasons for why there is another correct answer besides the keyed answer. Requested credit for his answer.
