Votes or final decisions are made only in open Regular or Special meetings, not in a work session or executive session.

2. **Minutes**
This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on September 1, 2022.
3. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**
This resolution sets the date and time for a public hearing on December 15, 2022, at 4:00 p.m. to determine whether certain conditions of the properties located at 2202 SW 1st Avenue, 110 NW 13th Avenue, 2412 W Amarillo Boulevard, and 1302 N Tyler Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.
4. **Resolution – Public Hearing**
This resolution conducts a public hearing on and considers ordering the removal of substandard structures and an accumulation of solid waste located at 110 S Fairmont Street.
5. **Resolution – Public Hearing**
This resolution conducts a public hearing on and considers ordering the removal of substandard structures and an accumulation of solid waste located at 2501 SW 6th Avenue.
