### 3. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:

This resolution sets the date and time for a public hearing on January 19, 2023, at 4:00 p.m. to determine whether certain conditions of the properties located at 88 N Bowyer Street, 403 S Kentucky Street, 2604 S Tyler Street Units A & B, and 2017 NW 19<sup>th</sup> Avenue constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.

## 4. Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:

This resolution sets the date and time for a public hearing on February 2, 2023, at 4:00 p.m. to determine whether certain conditions of the properties located at 705 S Houston Street, 2008 NW 16<sup>th</sup> Avenue, and 1104 SW 20<sup>th</sup> Avenue (AKA 1105 W Interstate 40) constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 508 N Madison Street.

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 901 N Polk Street.

### 8. Resolution - Public Hearing

This resolution conducts a public hearing on and considers ordering the removal of substandard structures located at 2916 Trigg Street.
