ITEM 1 <u>Call to Order and Announcements</u>

ITEM 3 <u>Discuss and Consider Minutes</u>

a) Staff Update

Ms. Massey introduced Megan Smith as new Board Secretary.

- b) Mural Grant Application Update and discussion (November 9th)
 - Ms. Massey announced that the Mural Grant Applications will open tomorrow (November 9th.) She has identified businesses in all four quadrants to reach out and share this news with and shared the dates of the program with the advisory board.
- c) TxDOT/Metropolitan Planning Organization

Ms. Massey announced that she attended the Metropolitan Planning Organization meeting. She asked that an agenda item be added to their next meeting involving their Beautification efforts on the MPO Project and hopes to find funding for the City's Entry points. Ms. Massey has also been in contact with Victoria of "Big City Chiefs" and gave Victoria the TxDOT information so she can reach out to TxDOT regarding the beautification efforts.

d) Sculpture update

Michael Kashuba discussed temporary art programs and the possibility of in the future of installing pedestals. Mr. Kashuba mentioned an individual (Orville) who creates public art in the country at his place of residence. He is considering building some temporary art sculptures for the art pedestals throughout the city. Ms. Massey mentioned her cousin Dick Baker who is also a big art enthusiast. Mr. Baker stated that him and his two neighbors both enjoy making art projects and have the to means to weld and cut metal. Ms. Massey also stated they're trying to figure out a way incorporate schools as well in the temporary art program. Mr. Kashuba mentions working with the purchasing department about figuring out a way to utilize left over materials and scraps to repurpose instead of just get rid of it. Mr. Boyett suggests turning it into an event or contest. Mr. Kashuba mentions the possibility of doing contests and having different categories for the competition with 6-8 winners that will have their projects displayed on the pedestals. Dr. Sauer also mentions the idea of just having pads put in place in the 6 parks and using those pads as art displays as well. Mr. Kashuba also states he wants to keep an open mind on the future projects and not just focus on one type of art. He loves the idea of temporary art projects because there is no concern

of upkeep and maintenance, but he also feels like there should be some money set aside for installation and maintenance on large sculptures throughout the city instead of having empty areas. There was also some discussion about performance art beautification projects, tree decorating etc. as ideas to add to the program.

e) Library Mural update

Ms. Massey had a meeting with Amanda Barrera, Stacy Clopton, with Shawn and Shanda O'Neil with Blank Spaces. It will move forward in conjunction with the Ignite Conference in April 2023. Plans are underway.
