3. **Minutes**
This item is for the Commission to discuss and consider approval of the Condemnation Appeals Commission minutes of the regular meeting held on December 15, 2022.
4. **Resolution – Calling a Public Hearing to determine whether certain conditions described herein constitute a Public Nuisance at the locations stated:**
This resolution sets the date and time for a public hearing on March 2, 2023, at 4:00 p.m. to determine whether certain conditions of the properties located at 203 N Independence Street, 202 N Madison Street, and 807 S Mississippi Street constitute dangerous structures and/or a public nuisance, and whether to order the removal of such. A copy of this resolution will be mailed to all interested parties providing ten (10) days' notice of public hearing.
