Item 1: Public Comment. There were no public comments.

ITEM 2: The Board will discuss or receive reports on the following current matters or projects:

- A. **AMW Activity Report.** Report for the last 3 months. The new officers are picking up a lot of animals. February shows 591 brought into the shelter with March at 720 and April at 794. There has been a huge drop in Humane Society rescues that is contributing to the shelter staying full. Kris spoke about the Adoption Department really picking up and us reaching out to other rescues. Bissel, being a big partner for us has helped us as well.
- B. **Staff updates.** New staff: We have 2 new animal care workers, Josh Miller and Marcellus Jackson. We also have 1 new field officer, Dustin Knight. We listed the positions that we need

to fill. Currently, we have 3 field officer trainee positions and 4 field officer II positions available. We went over our summer hours which are 7 am to 9 pm putting our on-call hours at 9 pm to 7 am.

- C. **Adoption Program Update.** We had our first volunteer program orientation on April 2. We have one per month planned.
- D. Community Outreach Update. We had a blood drive on April 30th. We had 10 doners. We also spoke about the pop-up clinic at San Jacinto Park where we gave 107 rabies, 94 DHPP vaccines, and 83 microchips. We attended the El Barrio Lions Club Cinco de Mayo Celebration. We have Muttfest at Starlight Ranch on May 15th and Juneteenth Celebration at Bones Hooks Park on June 19th. We also have the Pet Supplies Plus Dog Adoption Event every other Saturday. We have weekly media spots on KAMR, Wet Nose Wednesdays with the Eagle, and ABC Channel 7.
- E. Grants and Donations. We received a truckload of 20 pallets of hard goods from Chewy.
- F. **Texas Tech School of Veterinary Medicine.** Ribbon cutting April 22. AM&W has provided dogs to Texas Tech five times over the last several weeks. We transported between 4 and 33 dogs, and they stayed at Tech for 3 to 5 days. The students were able to perform physical exam labs.
- G. Next meeting. We set the next meeting for September 28, 2022.
