Caressa sent out the **Inclusion and Nondiscrimination Policies** for the board to review for board approval. Shanna moved to approve, Lilia seconded, and the board passes to approve the Policies unanimously.

Virginia announced that she was hoping to go to the HMIS conference on October 23-25th.

Gap Analysis committee: no report other than Kay has moved and we are looking for a new chair.

Ending Veterans homelessness: No report.
