VICINITY: Helium Rd. & Interstate 40

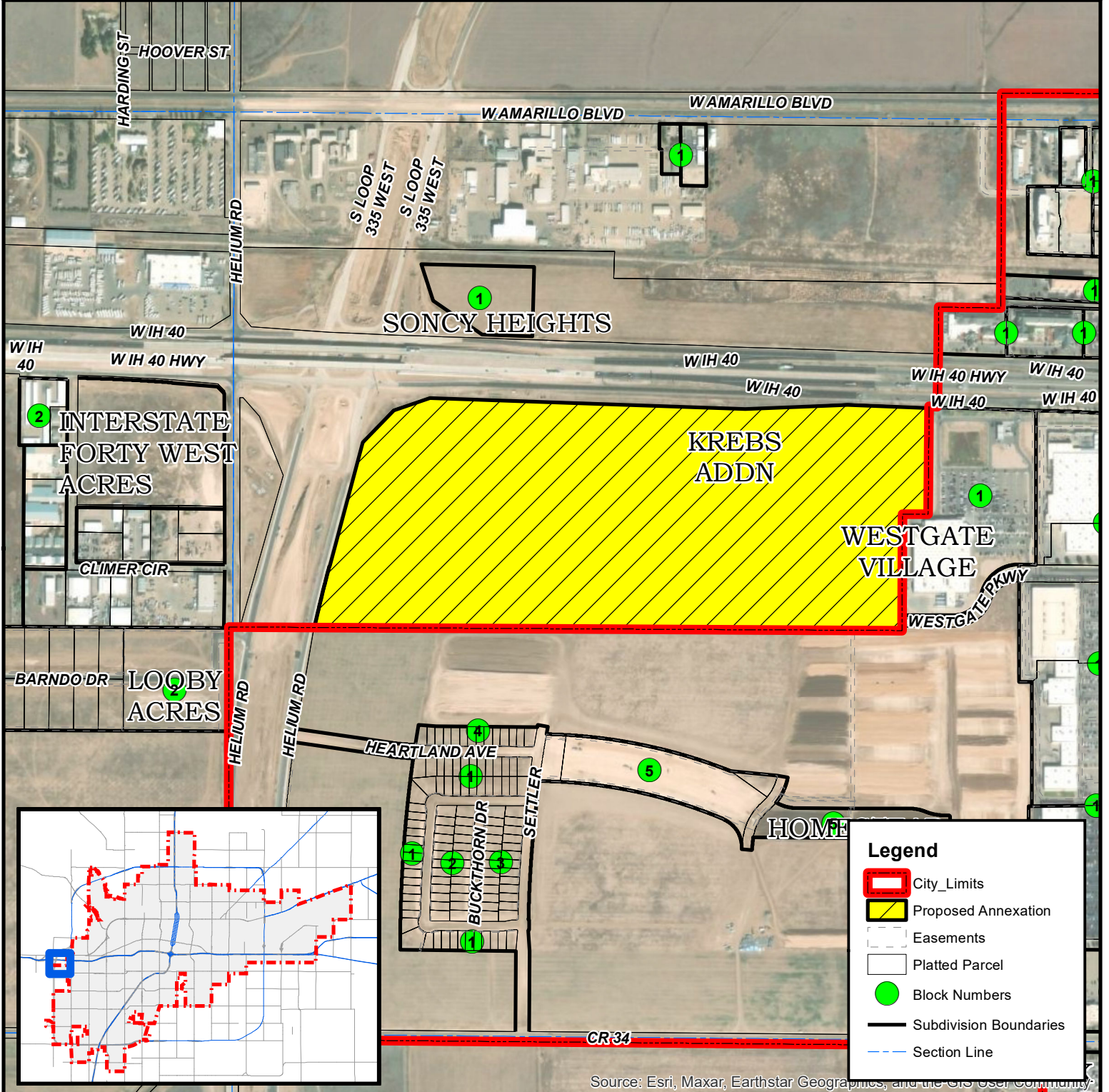
