APPLICANT/S: Highland Park Independent School District

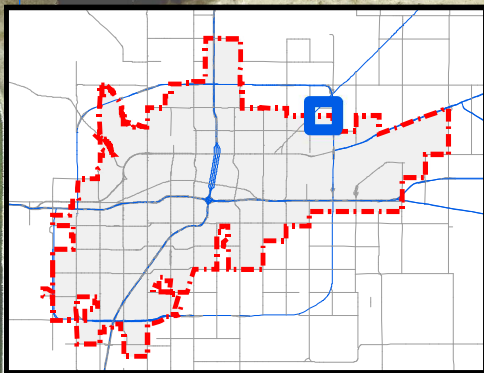
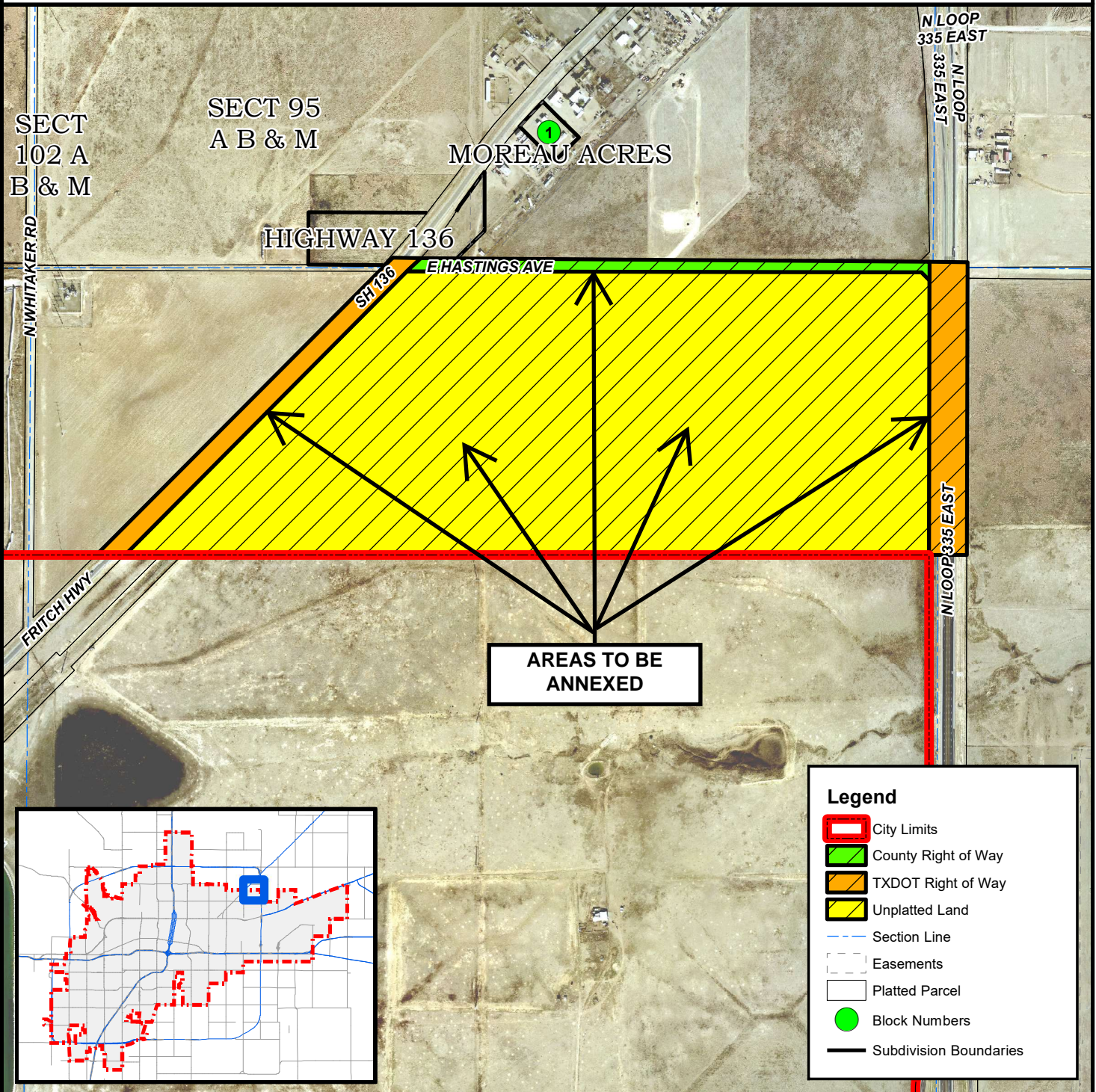
VICINITY: E. Hastings Ave. and Loop 335/Lakeside Dr.

In the event of a lack of quorum to convene or continue the meeting described above, then this matter will automatically be carried forward to the agenda of the next regularly scheduled meeting of the City Council and succeeding meetings as necessary.
