B.6. CONSIDER COUNCIL APPROVAL FOR DONOR-FUNDED SAFE HAVEN BABY BOX

This item seeks council approval to install a donor-funded Safe Haven baby drop box at Amarillo Fire Department Station 9, located at 2015 Paramount Blvd, Amarillo, TX 79109. The Safe Haven baby drop box provides a secure, anonymous way for individuals to safely surrender an infant under the Texas Baby Moses Law. The box is equipped with climate control, a silent alarm that alerts first responders within minutes of surrender, and is designed to protect the newborn while ensuring the privacy of the person making the surrender. This installation would offer an additional resource for the community, enhancing the city's commitment to the safety and well-being of its most vulnerable citizens.

B.7. CONSIDER COUNCIL APPROVAL FOR AMBULANCE PERMIT AMENDMENT

This item seeks council approval to amend the current Ambulance Permit to include the 911 Nurse Navigation Program. 911 Nurse Navigation is a program designed to provide appropriate care to low-acuity patients who call 911, without automatically dispatching fire or EMS resources. After an initial triage by a call taker at the Amarillo Emergency Communications Center, patients with non-emergency issues are connected to a nurse who conducts a more detailed assessment. The nurse then directs the patient to suitable healthcare options, such as urgent care centers, telehealth services, or mobile health teams, potentially using ride-share services. This program helps conserve emergency

resources for true emergencies while maintaining patient consent and satisfaction.
