New OSSF Application

- 1. New OSSF application and associated fees
- 2. All planning materials, according to Chapter 285.5(a).
 - a. A floor plan of the building structure(s) showing all outside dimensions of the building
 the floor plan does NOT need to be to-scale. All bedroom and other pertinent features (other rooms) must be shown on the floor plan.
 - b. A <u>scaled site plan</u> showing the location of the OSSF and all items specified in Chapter 285.30(b) relating to the Site Evaluation and Chapter 285.91(10) Table X relating to all pertinent features. <u>This site plan must be to-scale.</u> Pertinent features include items such as but not limited to, all surface waters (to include Flood Plain and Floodway Information), private and public wells, potable and non-potable water lines, OSSF system components, ditches or swales, property slope, swimming pools, easements, concrete pads, sidewalks, driveways, and a North-arrow for spatial reference.
 - c. If the property is too large to fit on a single sheet of paper, a Vicinity Map can be placed in the upper left corner to reference the location of the scale drawing
 - d. A legal description of the property where an OSSF is to be installed showing all easements, right-of-ways, etc.

Existing OSSF Application

- 1. Existing OSSF application and associated fees
- 2. All planning materials, according to Chapter 285.5(a).
 - a. A floor plan of the building structure(s) showing all outside dimensions of the building
 the floor plan does NOT need to be to-scale. All bedroom(s) and other pertinent features (other rooms) must be shown on the floor plan.
 - b. A site plan showing the location of the OSSF and all items specified in Chapter 285.30(b) relating to the Site Evaluation and Chapter 285.91(10) Table X relating to all pertinent features. This site plan does NOT have to be to-scale. Pertinent features include items such as but not limited to, all surface waters (to include Flood Plain and Floodway Information), private and public wells, potable and non-potable water lines, OSSF system components, ditches or swales, property slope, swimming pools, easements, concrete pads, sidewalks, driveways, and a North-arrow for spatial reference. Our department may have an old site plan on file that may have some or all the information required. A professional survey may also aid in the development of the site plan.
 - c. A legal description of the property where an OSSF located showing all easements, right- of-ways, etc.
