The Collaborative Applicant will utilize grant funds to support the Amarillo CoC in various ways. The planning grant aims to provide strategic planning, enhance HMIS implementation and coordinated assessment, increase the diversity of CoC membership, and offer training on evidence-based practices known to end homelessness, such as Housing First, Trauma-Informed Care, and Diversity, Equity, and Inclusion approaches.

1.Coordinating the Implementation of a Housing & Service System in the City of Amarillo:

a. Street Outreach, Engagement, and Assessments:

- i. Coming Home will provide street outreach/engagement for those experiencing chronic homelessness.
- ii. Tailored assessments will be created for each agency participating in HMIS.

b. Supportive Services:

- i. Coming Home will provide supportive services to those experiencing chronic homelessness.

The CoC has made significant progress toward becoming a high-performing organization. Its Board consists of volunteers from diverse service organizations, each balancing full-time jobs. With the dedicated support of a grant monitor, the CoC benefits from focused attention on compliance and improvement initiatives, as the grant monitor can synthesize and communicate these needs with the Board and its members. This grant monitor takes on responsibilities that were previously managed by Board members and staff from the Lead Agency, who often lacked the time and focus necessary for the CoC's healthy development. During the previous CoC competition, the score for the CoC's collaborative application drastically improved as a result of the improved performance of the CoC. The funding will enable us to gather precise data and highlight the importance of reliable information to determine necessary services. The intended trainings designed for the City of Amarillo's CoC will elevate the focus provided to clients, reducing negative discharges, and shortening the duration of homelessness. The strategic plan will offer a roadmap for the entire community, serving as a reference to all agencies seeking funding and partnerships.



1. West Texas A&M University Social Work Department agrees to provide these services to the CoC Board, valuing \$6062.50;
2. Will maintain records documenting services and values provided to Amarillo CoC (TX611CoC) and
3. Will make available these records to the City of Amarillo or the U.S. Department of Housing and Urban Development upon request.

### **IV. TERM OF AGREEMENT:**

This Memorandum of Understanding will be effective for FY2024 Continuum of Care Program Year beginning June 1, 2025, and ending May 31, 2026. Either party may terminate this agreement with 60 days written notice.

This Memorandum of Understanding may be amended by written mutual agreement.
