The meeting was called to order at 6:00 p.m. and the following items of business were conducted:

Consider Minutes

Motion to accept the minutes as written was made by Mayor Paul Harpole, seconded by Tom Johnson, motion passed.

Distribution of information

Julie White handed out information on the following:

- Recycling List (City of Amarillo Recycling centers information)
- List of topics discussed by the environmental task force.

Residential Hazardous Waste Recycling

Dave Lehfeldt informed the committee about that the City of Amarillo's Household Hazard Waste program. He provided a handout about the program, items that are accepted, and not accepted. Household hazardous waste items are accepted at the Environmental lab at 4001 S Osage for sorting and recycling or disposal by appointment only. Appointments may be scheduled by contacting (806) 342-1556 or (806) 342-1528. This information is also available on the City of Amarillo's web site.

Discussion was held about battery recycling. Private companies will recycle all types of batteries. The question of what the City of Amarillo does with their cores was discussed. Mayor Harpole requested information about what the City of Amarillo does with their cores.

City of Amarillo Environmental Task Force

Review of Action Items

Tire recycling

- Discussions were held as follows:
 - Dave informed the committee that over 35,000 tires were disposed of improperly last year. Tires are not allowed in the landfill, the City must pay a third party company to haul off the tires collected.
 - Mayor Harpole spoke about the tire dumping problem in Amarillo and informed the committee about the new ordinance and that was put in place to help combat the problem.
 - The cost companies charge to dispose of the old tires when new tires are purchased vs. what the landfill charges to dispose of tires.
 - o Increasing the charge at the landfill for tire disposal
 - Purchasing a Tire shredder to reduce cost of tire disposal
 - Cost of Tire Shredder \$95,000 \$250,000
 - o State tire disposal regulations vs. City of Amarillo tire disposal ordinance
 - Mayor Harpole recommended that the landfill policy be changed with regards to acceptance of tires and coordinated with the new rules and ordinances. Dr. Johnson made the motion to create a draft ordinance to review at the next meeting to present to the City council Mr. Graham seconded, motion passed.

Concrete / Asphalt recycling

- Discussions were held as follows:
 - Commercial recycling
 - LA Fuller having concrete recycling at their plant
 - Concrete and Asphalt recycling companies
 - How recycled asphalt and concrete can be used as base material in roads.
 - Concrete companies washing out concrete trucks on City property

Glass Crusher

- Dave Lehfeldt provided the following information:
 - o Provided a hand out to the committee about a glass crusher
 - Provided a sample of crushed glass
 - Explained how crushing glass could save room in the landfill
 - The end product of the crushed glass is a silica like sand
 - Uses of silica sand resulting from crushed glass
 - Cost of glass crusher
