Purpose of this Report

The Amarillo Metropolitan Planning Organization (MPO) is required by the Infrastructure Investment and Jobs Act (IIJA) to publish or otherwise make available an annual listing of projects, including investments in pedestrian walkways and bicycle transportation facilities, for which federal funds have been obligated during the previous fiscal year. The listing shall include projects identified in the Amarillo Transportation Improvement Program. Obligated projects in this report are listed by Federal-Aid Project Number and include highways, transit, bicycle and pedestrian, and other grouped projects. This report provides an overview of the transportation planning and programming process and the resulting federal funding obligation of the Transportation Improvement Program (TIP).

This report lists projects which were federally obligated in the 2022 fiscal year (October 1, 2021– September 30, 2022). An obligation is the federal government's commitment to pay its fair share of the project cost. This obligation happens at the time when the project is executed, and the State or Grantee requests the funds. For Federal Transit Administration (FTA) projects, obligation occurs when the FTA grant is awarded. In summary, an obligated project is one that has been approved by the federal government for reimbursement. Projects contained in the Annual Project Listing (APL) may not have been initiated or completed in the fiscal year.

Metropolitan Planning Organization (MPO) Information

The Amarillo Metropolitan Planning Organization (MPO), acting through the City of Amarillo Development Services Department and coordinating with the Texas Department of Transportation, is responsible for coordinated, comprehensive, and continuing transportation planning for all modes of surface transportation in the Amarillo Metropolitan Planning Area. The Amarillo MPO serves the cities of Amarillo, Canyon, and parts of Potter, and Randall Counties. The MPO is governed by elected and non-elected officials from the area.



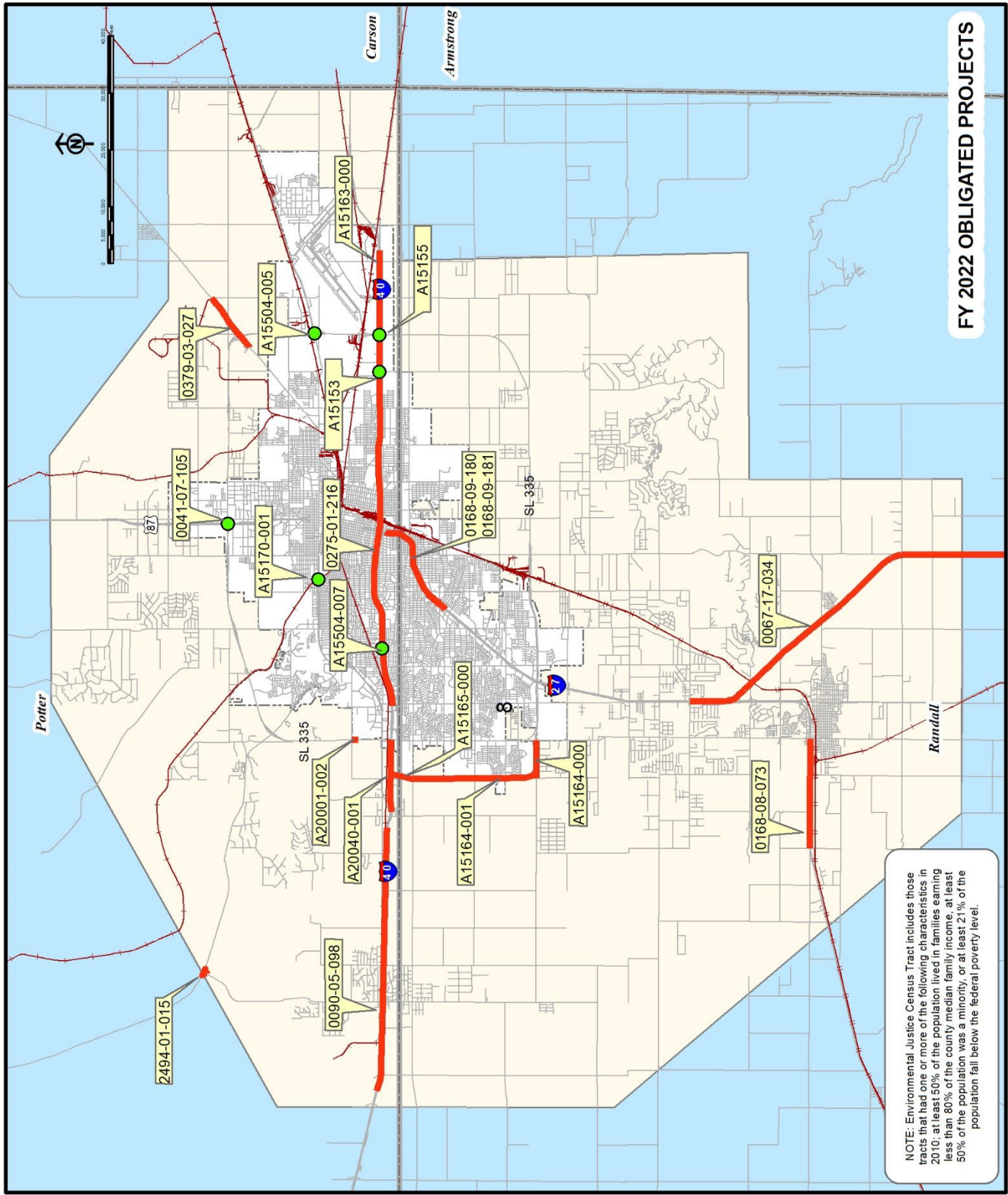
ACCESSIBILITY STATEMENT
